- Audit Quotes—We received a quote from Luke Malecki, which is the firm that the county contracts to do their audits. Ryan will forward an example of a RFP another county used to get audit quotes and he will also send contact information for audit companies.
- **Budget-** Alice presented the Board with a draft of the 2024 budget proposal. It was discussed if the new budget would allow a new vehicle. The Board would like to consider an electric vehicle as a replacement for the 2022 Ford Escape. The Board would also like a copy to review of the guidelines for Part A incentives.
- **NEACD/NYACD-**The Northeast Regional Conference will be held in Maine 9/17-9/20, 2023 Alice will be attending this conference with the CDEA. The NYACD annual meeting and training

will be held in Penn Yan 10/24-10/26, 2023. Alice and Renee would like to attend. The Board approved sending out payment of \$1,008.00 for registrations plus any travel expenses.

- **Budget Amendment-** A **MOTION** was made by Leerkes, seconded by Davis, and carried to amend the expense line 405 District Tree Program by \$1,608.00 making the total budget \$11,608.00 transferring the \$1,608.00 from Revenue line 2160F Tree and Shrub making total income \$11,608.00.
